## FOUNDATIONAL POLICY PRINCIPALS

### OVERVIEW

**OUR MANDATE** – upon being elected we will create a new Constitution and Federation for all Canadians that imbibes true freedom

**HEALTH** - Canadians right to choose family health care protocols / natural holistic protocols and / or mainstream medicine / introduce plant based medical protocols
